# 2010 June Crime Watch Report



Hello neighbors. As you may have noticed crime is way down in Richland Park and Oaks. There have only been one home burglary and the owner could not find anything missing, and one attempted break in. Auto Burglary, only 3 in the last couple of months that were reported to Police. If your car or truck is broken into please report it to police. Remember, if you want to keep it don't leave it in your car or truck, it's just a matter of time before a thief finds it. Beware of wheel thefts. There is a group of thieves taking wheels off trucks and SUV parked in driveways and on the street. They are quick, but do put your vehicle on blocks.

Helpful Hints:

Never leave your car running while unattended. You could also be issued a citation for it.

Always lock your car. Approximately 50% is all cars stolen were unlocked.

Keep all valuables and packages out of sight. These can encourage thefts.

Drop business card, address labels or other types of I.D. inside vehicle doors by dropping them down the window channel.

School will be out soon and crime will go up for the summer. Be suspicious of ANY-ONE walking or driving up and down our alleys, they are up to no good and call RPD at once. They will check it out. You can tell your neighbor that you don't know your sorry later. The best way to deter crime is to get to know your neighbors and help watch out for each other. Trade home and work phone numbers, let them know when you are going to be gone, also let Crime Watch know when you are gone.

I need more Crime Watch Patrol volunteers. We have had several move out of the area this year and I need replacements. It only takes a couple of hours every two weeks and I find it fun and very rewarding. I need people for all shifts, so there is a time that fits your schedule. If you would like to know more about Crime Watch and what is involved give me a call and I will explain what we do. You can even go on a ride along to see if this is for you, but beware if you do you are hooked. You will want to join right then and there.

# VEHICLES' BELONG IN THE GARAGE SAYS "CITY OF RICHARDSON FIRST RESPONDERS"

The garage provides protection from theft, and from Mother Nature.

As we drive in the neighborhood, we can't help but ask, "Why are there so many cars parked out on the street?" Not only are these cars an eyesore to the neighborhood, but they are also in the way of



traffic flow. Can you imagine if we had to get a large fire truck or ambulance quickly through our neighborhood?

"Plus it is illegal to park in front of *fire hydrants* or *within 30 feet of an intersection* and *parking the wrong way on the wrong side of the street*." says COR First Responder"

Not to mention these same cars tend to attract criminals into our neighborhood. The only safe place for cars is the garage. Whether you park your car in the front or in the back alley, it may eventually get broken into. Cars parked inside a fully closed garage almost never have problems with crime.

So we encourage you to clean out the few hundred dollars of stuff polluting your garage, and start parking your multi-thousand dollar cars in your garage!

"<u>Please clear the streets by cleaning out your garage</u>." "If you're afraid to pull into your garage by yourself, keep your vehicle doors lock until you lowered your garage door to get out of your vehicle to enter your home."

If for some reason you must keep your cars parked out of the garage, **please take everything out each and every night**! This includes the obvious items like cash, laptops, loose change, purses, wallets, jewelry, briefcases, games, toys and the not so obvious items like empty bags (the criminal doesn't know its empty until he breaks in), **garage door openers** (the key to your house), and your insurance and registration papers. You may also consider investing in a good car alarm.

But please keep the streets clear for City of Richardson First Responders. It may be your home or life they are trying to save next time.

... and sometimes that matters a lot. It mattered to me when I had back surgery and couldn't get to the pharmacy for a new prescription. It mattered when I couldn't bend over to pick up my newspaper from the front porch each day.

And someday it may matter to you. But, happily, someone else has thought about these special needs! And that care comes from the Richland Connections Committee (RCC, for short), a group of your friends in the Richland Park and Richland Oaks neighborhoods. These men and women meet regularly to discuss how people in our neighborhood get the short-term help they need to manage their special requirements.

Here are some of the things that RCC helpers have done in the last few months for their neighbors in Richland Park and Richland Oaks:

- " ! Set up a pill organizer for a senior citizen and filled it each week
- " ! Checked in on a person, both in person and by phone
- " ! Took a person to a doctor's appointment
- " ! Walked a dog
- "! Took a meal to a shut-in
- "! Visited with a person who seldom has visitors
- "! Took a person to lunch
- "! Went for a drive with a person who seldom gets out of the house
- " ! Picked up a prescription
- "! Changed burned-out light bulbs
- "! Protected pipes from freezing during the winter
- "! Helped repair a smoke alarm
- " ! Kept track of medical appointments (and sometimes provided transportation)
- "! Made arrangements for a cleaning person for a shut-in
- "! Provided transportation to work for a person with a broken ankle
- "! Made and delivered some cookies (and conversation)
- " ! Shared some homemade soup
- " ! Picked up mail for a person who recently had surgery
- " ! Did grocery shopping for a shut-in
- " ! Provided trustworthy referrals for various services

The idea is to help people with special needs. But there's another side to this proposition: helping others makes the heart swell with happiness! That's what motivates people in RCC. It's a win-win for everyone.

When you have a need, or know of someone in Richland Park or Richland Oaks who needs short-term help, please let RCC know. Carolyn Murphy is our designated go-to person. Call her at 972-234-6043. It's all about taking care of each other!
